Treated between January and October 1909 by Dr. Chas. Armstrong Lumley MRCS (Eng) LRCP (Lond) DPH (Cantab) for "Disease of the Brain"; certificate issued 29<sup>th</sup> October 1909.

Applied October 1909 for permission to retire which was recommended by the Postmaster General "on account of physical infirmity ... (his duties having been discharged) ... with diligence and fidelity and to my satisfaction". Was awarded a pension of £70/17/11 per annum by the then Prime Minister, John X Merriman, on 21 December 1909. From the outset, it was paid to his wife.

Committed to an asylum 30<sup>th</sup> March 1910 by acting Resident Magistrate of Grahamstown, FL Osman.

Died 22 October 1911 in Fort England Asylum, Grahamstown aged 40 years and 6 months. Following on a accident - he is said to have fallen off his horse - through which he incurred an head injury. The outcome suggests the development of a chronic subdural effusion which, without surgical intervention, led to his demise.

Died of "adreno-cortical failure" [sic] in Sir Henry Elliott Hospital, Umtata aged 57 years and 10 months. The Will is detailed. The Estate was valued at R. 8022.14 after expenses. Beneficiaries: wife and 2 sons. It consisted of shares, cash, defined moveable items and a property "Seaside Resort Site at Umgazana in Location No. 14 called Gomolo, Port St. Johns, Transkeian Territories".
